THE *DECANO* OF FULL PROFESSORS

HAVING REGARD to the Statute of the IMT High Studies Lucca School, issued with Directorial Decree n. 05973 (214).I.2.02.07.19, published in the Official Gazette, General Series - n. 163 of July 13, 2019, amended by Directorial Decree no. 03610 (160) .I.2.22.04.21 published in the Official Gazette, General Series, no. 108 of May 7, 2021;

WHEREAS the *Decano* is the IMT School full professor with the highest seniority amongst his or her peers. Seniority being determined by the date of appointment as a full professor; in case of equal seniority in the role, age prevails;

HAVING REGARD to the law of December 30, 2010, n. 240 "Rules on the organization of universities, academic staff, and recruitment, as well as a mandate to the government to encourage the quality and efficiency of the university system" with particular reference to art. 2;

HAVING REGARD to the Regulations for the election of the Director of the IMT School for Advanced Studies Lucca, issued with Directorial Decree IMT Prot. n. 4070 (176) I.3.05.05.21;

HAVING REGARD to the MIUR decree prot. n. 00857 of October 30, 2015, which appointed Prof. Pietro Pietrini as Director of the IMT School for Advanced Studies Lucca with effect from November 1, 2015, and the subsequent renewal prot. MIUR n. 00173 of February 28, 2019, with specific reference to art. 8 and the procedure for electing the Director, and art. 25, paragraph 2, regarding the system of sources of the IMT School;

WHEREAS the mandate of the Director in office shall cease on October 31, 2021;

WHEREAS the need to call for the elections of the Director of the IMT School for Advanced Studies Lucca

DECREES

Art. 1. Announcement

1. The elections of the Director of the IMT School for Advanced Studies Lucca for the three-year period 2021-2024 are announced.

Art.2 Voting schedule

1. The election of the Director of the IMT School for Advanced Studies Lucca will follow the voting schedule below:

Tuesday, July 13, 2021, from 9.00 am to 6.00 pm
Friday, July 16, 2021, from 9.00 am to 6.00 pm
Wednesday, July 21, 2021, from 9.00 to 18.00
First Voting Round
Possible Ballot

Art. 3 Eligibility for election

1. The Director is elected by secret ballot among full professors with recognized international scientific qualifications and deep knowledge of the research system in Italy and abroad. The Director-elect must hold an appointment at an Italian university or higher education institute for advanced studies and guarantee a number of years of service equal at least to the duration of the mandate before the retirement date.



2. Those in a part-time status may apply provided that, along with the application, they agree in writing to opt for full-time status if elected.

Art. 4 Applications

- 1. Applications must be received no later than **12:00 pm on June 1, 2021**, through a formal written statement addressed to the *Decano* of the IMT School for Advanced Studies Lucca (domiciled for these purposes at the General Affairs Office of the School) and indicating in the subject "Application for the position of Director of the IMT School for Advanced Studies Lucca" through one of the following:
 - a) by registered mail with acknowledgement of receipt, with subject "Candidacy for Director of the IMT School for Advanced Studies Lucca" on the envelope, addressed to:

- b) hand-delivered to the Registry office, at the address indicated above, from Monday to Friday from 9.00 to 12.00;
- c) by e-mail to **imtlucca@postecert.it**, via certified e-mail (PEC), with a digital signature put on the application and on all the other documents where a handwritten signature is traditionally required.
- 2. In any case, the envelope must be received no later than the announcement's deadline.
- 3. The application must be accompanied by:
 - a) application for candidacy based on the attached model;
 - b) curriculum vitae, without any personal data, because it will be made public; only name, surname, and institutional contacts are allowed;
 - c) copy of a valid identification document with date and handwritten signature.
- 3. The IMT School accepts no responsibility for any failure to communicate due to incorrect information on the residence, delivery, and e-mail addresses provided by the applicant or due to failure or late notification of any address changes, nor for any postal, telegraphic, or IT problems not attributable to the fault of the School itself.
- 4. Candidates who have not submitted an application form filled in all its parts, duly signed and dated, will be excluded from the selection.
- 5. Applications will be published on the institutional page of the School's website www.imtlucca.it/it/the-imt-school/job-opportunities/academic-positions/direttore.
- 6. Candidates may submit their electoral program in the manner indicated in paragraph 1 and, in any case, by the date set for the General Assembly of the Electoral Body. Electoral programs will be published on the same institutional page indicated in paragraph 5.

Art. 5 Eligibility to vote

1. Those eligible to vote in the election of the Director are full and associate professors at the IMT School and the following categories, whose vote is weighted such as to ensure that each of them carries a weight specified as follows:



- a) Researchers and research fellows of the IMT School with a weight of 15% of the overall votes
- b) Technical-administrative staff of the IMT School with a weights 10% of the overall votes
- c) IMT School students with a weight 5% of the overall votes

2. Those eligible to vote are:

- a) Full and associate professors;
- b) Professors/researchers of other Universities who serve at the School to the extent of 100% through an agreement under art. 6, paragraph 11, of Law 240/2010;
- c) Type B fixed-term researchers, type A fixed-term researchers, research fellows;
- d) Technical-administrative staff with permanent and fixed-term contracts and employees of other public institutions who serve at the School in leadership roles, temporary assignments, or equivalent positions;
- e) All students enrolled on the date of the election;
- f) Personnel at points a, b, c, d, on leave under current legislation.
- 3. The following categories are not eligible to vote:
 - a) Professors/researchers of the IMT School serving at other universities to the extent of 100% through an agreement under art. 6, paragraph 11, of Law 240/2010;
 - b) The technical-administrative staff of the School employed at other institutions in leadership positions, temporary assignment or equivalent positions;
 - c) Students during the expulsion for a set time longer than three months for disciplinary reasons.
- 4. The requirements to exercise the right to vote must be possessed on the election date. To this end, fifteen days before the first voting session, the *Decano* issues an update of the lists of eligible voters.
- 5. Requests for rectification may be submitted within five days from the adoption of the act referred to in the preceding paragraph. After this date:
 - any increase (new hiring, transfer, etcetera) does not affect the active electorate;
 - any decrease (termination, transfer, etcetera) produces effects on the active electorate.

Art. 6 General Assembly of the Electoral Body

Candidates will present their programs during the General Assembly of the Electoral Body, which will take place at **11.30 am on June 22, 2021**, at the headquarters of the IMT School for Advanced Studies Lucca. It will also be possible to attend the Assembly remotely. Participation instructions will be communicated later via the School's intranet on the appropriate dedicated page. To identify a suitable venue and ensure in-person participation by all who wish to participate, while ensuring compliance with the contagion prevention measures, we ask to confirm in-person participation **no later than 12:00 pm on June 5, 2021**, by completing the appropriate online form that will be shared with the School Electoral Body in due time.



Art. 7 Voting procedures

- 1. Voting is personal, free, and secret.
- 2. The elections will be held remotely electronically through the School's electronic voting platform. It is possible to vote from anywhere with devices equipped with an internet connection and a recent browser, on the indicated days and times, using strictly personal and unique login information. The operational guidelines to access the voting system will be published on the dedicated page of the School's intranet in time for voting.
- 3. Each elector expresses a single preference. Individual voters must ensure absolute confidentiality and secrecy in the exercise of their vote, which must take place in the absence of third parties, noting, however, the relevant civil and criminal liabilities ascertained by the competent authorities. It is prohibited to disseminate images and videos of the voting operation performed.
- 4. At the end of each voting round, a tally will take place. At the end of each tally, a specific report will be compiled.

Art. 8 Polling office and station

- 1. At least seven days before the date set for the elections, the *Decano* shall appoint by order the election office by their own provision, identifying its members among those eligible to vote, guaranteeing in any case the representation of all School categories. In particular, the office shall be composed of:
 - a) the *Decano*, as Chairperson;
 - b) a full professor;
 - c) a representative of the researchers (type B fixed-term researchers, type A fixed-term researchers, research fellows);
 - d) a representative of the technical-administrative staff;
 - e) a representative of the students of the Ph.D. programs.
- 2. A Polling Station will be set up in the Conference Room of the administrative headquarters of the School located in Piazza San Ponziano, 6 Lucca, in order to provide the necessary equipment for those who cannot vote according to the procedures described in the previous articles. The voting system is the same as in art. 7.

Art. 9 Conduct of the elections

- 1. In the first round of voting, the Director shall be elected by an absolute majority of the weighted votes, which may be cast.
- 2. In the second round of voting, the Director shall be elected by an absolute majority of the weighted votes cast.
- 3. In case of non-election in the second voting session, if there is only one candidate, the *Decano* shall call new elections under the Regulations for the Elections of the Director of the IMT School. If, instead, there are two or more candidates, a ballot will take place within the following three working days between the two candidates who received the highest number of preferential votes in the second voting session, provided that the sum of those votes exceeds fifty percent of the weighted votes cast. If the conditions for the ballot are



not met, the *Decano* shall call new elections under the above-mentioned Regulations for the Elections of the Director of the IMT School.

- 4. For the election to be valid, the participation of the majority of those entitled to vote is required in the first two voting sessions, taking into account the weightings referred to in art. 2, paragraph 3 of the Regulations for the Elections of the Director of the IMT School. In the ballot vote, the participation of one-third of eligible voters is sufficient, considering the weightings referred to in art. 2, paragraph 3 of the above-mentioned Regulations.
- 5. If the quorum for the validity of the ballot is not reached, the *Decano* shall call new elections under art. 3 of the Regulations for the Elections of the Director of the IMT School.

Art. 10 Privacy policy

- 1. The conditions, facts, and personal qualities self-certified by the successful candidate are subject to appropriate checks, including sample checks, by the School, regarding their truthfulness.
- 2. Under EU Regulation 2016/679 and Legislative Decree 6.30.2003, n.196, the School is committed to respecting the confidential nature of the information provided by the candidate; all data provided will be processed only for the purposes related and instrumental to the procedure and the possible election, in accordance with current regulations.

Art. 11 Publicity

1. This provision is published in the IMT School for Advanced Studies Lucca online register and website and e-mailed, for information, to the CRUI and Italian universities.

Art. 12 Organizational unit responsible for the process

1.
